CARDINAL LUXURY SPA INSTALLATION INSTRUCTIONS



The Luxury Spa must be installed by placing footwell (bottom of the spa) on a solid surface such as concrete or block that is free of debris that may dent or crack the footwell. Never use the lip of the spa to support the unit, the weight of the water will cause the spa to flex slightly which could result in cracking if the spa is not supported correctly.

PLUMBING INSTRUCTIONS:

For best spa performance the recommended filtration equipment should be no more than 50' from the spa.
All plumbing lines should be run independently in 2" Rigid or Flex PVC to the filter pad. (Do not "Tee" the lines to together underground.)

12 Jet Spas are pre-plumbed with a 2" line for suction and a 2" line for return. These lines should be connected to a 1 ½ hp pump for best spa performance. When using the spillway spa, water is removed from the pool and returned to the spa for the spa to overflow into the pool. A check valve should be installed on the spa return line to prevent equalization when the system is not in operation.

25 Jet Spas are pre-plumbed with 2 suction lines and 2 return lines. The spa suction line and spa return line should be plumbed to the main pool filter pump, while the booster lines should be plumbed to a separate 1 ½ hp pump for best spa action. When using the spillover spa, water is removed from the pool and returned to the spa for the spa to overflow into the pool. A check valve should be installed on the spa return line to prevent equalization when the system is not in operation.

** If you are winterizing the spa, please remove all jet and suction faceplates, blow and plug all lines, and refill the spa to normal operating levels to avoid frost or ground water lifting the spa out of the ground.

Manufacturer warrants the DuraShell® interior against peeling, cracking, yellowing, blistering, or delamination for
	a period of five years from date of purchase. Spa shell, jet fittings, internal plumbing, internal glue joints, and all bonded parts are warranted against
ł	leaks for a period of one year from date of purchase.
