
ULTIMATE POOL STEEL PANEL LIMITED LIFETIME ONE TIME TRANSFERABLE WARRANTY

This warranty of the Ultimate pool steel panel components is valid to the original purchaser or the first subsequent owner for a "lifetime." If the panel rusts or corrodes beyond usage during this period, the manufacturer agrees to repair or replace the defective part. Panel damage due to snow or ice load will be covered under the terms of this warranty only if the pool is installed in accordance with the manufacturer's specifications.

This warranty is subject to the following terms and conditions:

Panel failure due to rust, corrosion, or winter damage Notify the factory in writing and identify the panel. The manufacturer will repair or replace, at their option, within thirty (30) days of receipt of the defective panel. The defective panel must be shipped freight pre-paid and the replacement panel will be shipped back freight collect.

This warranty is valid to the original purchaser only, provided the attached warranty registration form is completed and submitted via mail to the manufacturer within thirty (30) days after purchase.

To take advantage of the one time transferable warranty, you must write to Fox Pool Corporation to request the warranty transfer package. This warranty transfer package is available for a one time fee of \$99.00. The warranty transfer package information must be completed and returned to Fox within ninety (90) days of the date the property where the Product was originally installed was transferred to the subsequent consumer owner.

All labor costs for removal and re-installation of defective panel and all freight charges shall be paid by the original purchaser and will not be reimbursed.

Units or assemblies such as pool liner, pool coping, filters, pumps, motors, skimmer, standard fittings, heaters or accessories purchased for use in the pool are subject to and carry the original manufacturer's warranty.

Manufacturing is located at 3490 Board Road, York, PA 17406 and is open for business Monday through Friday from 8 a.m. to 4:30 p.m.

The manufacture's total liability under this warranty is limited to carrying out the terms of this warranty. No expressed, implied or statutory warranty other than that set forth herein is made or authorized to be made by the manufacturer.

The manufacturer has no liability for faulty installation of the pool or for damage to panels which may result from faulty handling or installation. Failure to strictly follow installation instructions will void all warranties as deemed by the manufacturer.
