## ASSEMBLY TIPS

- Layout all the parts and verify that they are all present according to the Parts and Hardware list.
- Some figures or drawings may not look exactly like the product.
- Hand-tighten all bolts in place and then tighten with a wrench once fully assembled.



## ASSEMBLY INSTRUCTIONS

NOTE: IF USING A SIDE MOUNT SETUP, SKIP TO STEP 5.

## STEP 1

Attach the Support Uprights (GG) to the Base Plate (FF) using the Round Head Bolts (A), Washers (G), and the Round Head Nuts (N).


## STEP 2

Make sure the spa is empty and slide the Base Plate/Support Upright assembly under the center of the back of the spa cabinet. This will be the side the spa cover will be stored behind. Make sure the Base Plate (FF) sits flat on the ground, with no overhang off the slab or deck.


## ASSEMBLY INSTRUCTIONS

## STEP 3

Slide the legs of the Lift Assembly (AA), with Pivot Arm (EE) attached, over the Support Uprights (GG).


## STEP 4

Loosely thread the (2) Adjustment Bolts (E) through the (2) Adjustment Bolt Washers (H) and into the threaded holes in the Support Legs. DO NOT tighten the adjustment screws yet.

TO CONTINUE WITH BASE MOUNT SETUP, SKIP TO STEP 7.


## ASSEMBLY INSTRUCTIONS

NOTE: Steps 5 and 6 are used only if using a side mount setup and NOT using the Base Plate (FF).


## STEP 6

Mount the Lift Assembly (AA) to the side of the spa using the (4) Lag Screws (Z).


## STEP 7

Slide the Lift Assembly (AA) up the Support Uprights (GG) until the Pivot Arm (EE) lines up with the top of the spa. Tighten the (2) Adjustment Bolts (E) that were threaded into the Support Leg hole in Step 4.

## STEP 8

Attach the left and right U-Arm assemblies (BB, CC) to the open tubes of the Pivot Arm (EE) using the spring buttons. Use the hole that will allow the U-Arms to swing as low as possible, without hitting the ground. Mount the Lift Assembly (AA) to the side of the spa using the (4) Lag Screws (Z).


## STEP 9

Swing the U-Arms up so that they are parallel to the ground. Raise the Pivot Arm (EE) so that the bottom tube is level with the top of the spa without the cover.

NOTE: If the folded spa cover is too thick to fit within the
U-Arms, use the U-Arm Extension $(\mathrm{HH})$ to widen the arms.

## STEP 10

Attach the (2) Ball Studs (L) and (2) Lock Nuts (K) to the tab and fin. Then snap the Hydraulic Lift (DD) over the round ends of the Ball Studs to lock in place.

## STEP 11

Push the (2) Lock Pins (F), one on each U-Arm, through the hole directly behind the spring button. Make sure the pin passes through the diagonal channel (not shown) on the U-Arm and comes out the other side to lock the arm in place.

## OPERATION INSTRUCTIONS

To use the Premium Cover Lift, follow the steps below.

A) Start with the cover on the spa and the Premium Cover Lift in stowed position.

C) Ensure that the Premium Cover Lift is deployed, as shown.

B) Rotate the arms outward and make sure the spring pins lock.

D) Fold the cover in half.

F) Push the cover downward.
